CLASSIC ROCK 97LAV'S "DREAM MACHINE" CONTEST OFFICIAL RULES

A complete copy of these rules can be obtained at the offices of radio station WLAV-FM ("Station"), owned and operated by Cumulus Radio LLC, 60 Monroe Center St. NW Suite 300, Grand Rapids, MI 49503, during normal business hours Monday through Friday or by sending a self-addressed, stamped envelope to the above address.

The Station will conduct the **Classic Rock 97LAV's "Dream Machine"** Contest (the "Contest") substantially as described in these rules, and by participating, each participant agrees as follows:

- 1. NO PURCHASE IS NECESSARY. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.
 - Eligibility. This Contest is open only to legal U.S. residents, excluding Florida and New York residents, age eighteen (18) years or older at the time of entry with a valid Social Security number and who reside in the Station's Designated Market Area ("DMA") as defined by Nielsen Audio, who have not won a prize from the station in the last 90 days or a prize valued at \$500 or more in the last 180 days, and whose immediate family members or household members have not won a prize from the station in the last 90 days or a prize valued at \$500 or more in the last 180 days. There may only be one (1) Qualifier per household and/or immediate family and a person may only qualify one (1) time during this Contest Period. The first person to qualify will be the one (1) and only one (1) Qualifier per household or immediate family member and all others are ineligible to enter. Void where prohibited by law. Employees of Cumulus Radio LLC, its parent company, affiliates, related entities and subsidiaries, promotional sponsors, prize providers, advertising agencies, other radio stations serving the Station's DMA, and the immediate family members and household members of all such employees are not eligible to participate. The term "immediate family members" includes spouses, parents and step-parents, siblings and step-siblings, and children and stepchildren. The term "household members" refers to people who share the same residence at least three (3) months out of the year. The Contest is subject to all applicable federal, state and local laws and regulations. Participation constitutes entrant's full and unconditional agreement to these Official Rules and Sponsor's decisions, which are final and binding in all matters related to the Contest. Winning a prize is contingent upon fulfilling all requirements set forth herein.
- 2. Contest Period. The Contest Entry Period will begin at 12:01am ET on Saturday, May 11, 2019 and will run through 11:59pm ET on July 31, 2019 ("Contest Entry Period"). The Winner Selection Period will run from 7:00am ET on August 1, 2019 through 6:59pm ET on August 14, 2019 (the "Contest Period"). The Contest will not run on May 27, 2019, and July 4, 2019. The Station's computer is the official time keeping device for this Contest.
- **3. How to Enter.** To enter:
 - (i) <u>On-Air</u>: Listen to the Station weekdays from 6:00amto 10:00am, 11:00amto 1:00pm, and 3:00pm to 7:00pm from May 13 through July 31, 2019 with the exception of May 27 and July 4, 2019. When the Station plays the "cue-to-call" sounder, listeners should call the Station at 616-459-9797. Caller nine (9) to the Station, as determined by the Station in its sole discretion, will receive two (2) entries for the Grand Prize drawing (as defined below). Station will play one (1) cue to call during each of the timeframes listed above per day (for a total of three (3) cues to call per day). There will be up to one hundred sixty-eight (168) on-air qualifiers. <u>Time Delay Between Over-the-Air Analog Signal and Internet Broadcast</u>: Due to the time delay that exists between the Station's analog over-the-air signal and the Station's online webcast, listeners who listen to the Station online may hear the cue to call later than listeners listening to the Station's analog over-the-air signal. As a result, the odds of an online listener entering this Contest on-air may be diminished.
 - (ii) <u>Pit Stop</u>: Attend a Dream Machine Pit Stop (each a "Pit Stop") conducted by Station and complete an entry form. Limit one (1) entry per person per Pit Stop. All entries must be received by the deadline stated at the Pit Stop. At the conclusion of each Pit Stop, Station will select five (5) entries in a random drawing from among all valid entries received by Station during that Pit Stop to qualify for the Grand Prize drawing. Station reserves the right to add, remove or otherwise modify the Pit Stops throughout the Contest Period at the Station's sole discretion.

(iii) <u>Online</u>: Visit the Station's website <u>www.WLAV.com</u> during the Contest Period, click on the "Contest" link, click on the "Dream Machine" Contest link, and complete an entry form. All entries must be received by 9:59 am ET on Wednesday, July 31, 2019 to be eligible for the Grand Prize drawing. On or about 10:00am ET on July 31, 2019, Station will select ninety-seven (97) entries in a random drawing from among all valid entries received by Station during the Contest Entry Period to qualify for the Grand Prize drawing. Limit one (1) entry per person per day per email address. Multiple participants are not permitted to share the same email address. Any attempt by any participant to submit more than one (1)

entry per day by using multiple/different email addresses, identities, registrations and logins, or any other methods will void that entry and the participant may be disqualified. Use of any automated system to participate is prohibited and will result in disqualification. Station is not responsible for lost, late, incomplete, invalid, unintelligible, inappropriate or misdirected registrations, all of which will be disqualified. In the event of a dispute as to any registration, the authorized account holder of the email address used to register will be deemed to be the participant. The "authorized account holder" is the natural person assigned the telephone number by the wireless carrier or an email address by an Internet access provider, online service provider or other organization responsible for assigning email addresses for the domain associated with the submitted address. Potential winner may be required to show proof of being the authorized account holder. All entries become the sole and exclusive property of Station and will not be returned. Station reserves the right to contact entrants and all other individuals whose email address is submitted as part of this promotion. No mail-in entries will be accepted.

4. Winner Selection. Each day during the Winner Selection Period, on or about 7:20am ET Station will select one (1) entry to be a Grand Prize Finalist in a random drawing from among all valid qualifying entries (on-air, Pit Stop and online) received by Station during the Contest Entry Period. Station will read the selected entrant's name on the air. The selected entrant will have nine minutes and seventy seconds (9:70) to call the Station at 616-459-9797 after their name is read to become a Grand Prize Finalist. If the selected entrant calls the Station within the time frame, they will be a Grand Prize Finalist. If the selected entrant fails to call the Station in the allotted time frame, the Station will then select another entry. Station will continue to select entrants and read names on air until the selected entrant calls the Station within the allotted time frame to become a Grand Prize Finalist.

Grand Prize Event. The ten (10) Grand Prize Finalists will be invited to attend the Grand Prize Event on August 14, 2019 at the DeltaPlex (2500 Turner Ave., Grand Rapids, MI 49544) prior to the Summertime Blues concert. On or about 6:00pm ET, Station will conduct a reverse drawing from among all Finalists in attendance. Station will select one Finalist's name at a time. The last name drawn will win the Grand Prize. Must be present to win. The winner will be notified at the time of the Grand Prize drawing and may be awarded the Grand Prize (subject to verification of eligibility and compliance with the terms of these rules). Station's decisions as to the administration and operation of the Contest and the selection of the potential winner are final and binding in all matters related to the Contest. Failure to respond to the initial verification contact within three (3) days of notification will result in disqualification.

- Verification of Potential Winners. POTENTIAL CONTEST WINNERS SUBJECT TO VERIFICATION BY STATION WHOSE DECISIONS ARE FINAL AND BINDING IN ALL MATTERS RELATED TO THE CONTEST. The potential winner must continue to comply with all terms and conditions of these Official Rules, and winning is contingent upon fulfilling all requirements. The potential winner will be notified by email and/or telephone call after the date of random drawing and/or winner determination. The potential winner will be required to sign and return to Station, within three (3) days of the date notice is sent, an affidavit of eligibility and a liability/publicity release (except where prohibited) in order to claim his/her prize, if applicable. A winner who returns the affidavit of eligibility and liability/publicity release will be deemed to have accepted the Contest Prize and thereafter will not be permitted to rescind their acceptance of the prize and/or return the prize. If a potential winner cannot be contacted, fails to sign and return the affidavit of eligibility and/or the liability/publicity release within the required time period (if applicable), or if the prize or prize notification is returned as undeliverable, potential winner forfeits prize. - **Grand Prize.** One (1) Grand Prize will be awarded in this Contest. The Grand Prize is a remodeled 1998 Toyota Land Cruiser. **ARV** Thirty Seven Thousand Dollars (\$37,000). Station reserves the right to cancel, suspend and/or modify the Contest, or any part of it, if any fraud, technical failures or any other factor beyond Station's reasonable control impairs the integrity or proper functioning of the Contest, as determined by Station in its sole discretion. Station reserves the right in its sole discretion to disqualify any individual it finds to be tampering with the entry process or the operation of the Contest or to be acting in violation of these Official Rules or any other promotion or in an unsportsmanlike or disruptive manner. Any attempt by any person to deliberately undermine the legitimate operation of the Contest may be a violation of criminal and civil law, and, should such an attempt be made, Station reserves the right to seek damages from any such person to the fullest extent permitted by law. Station's failure to enforce any term of these Official Rules shall not constitute a waiver of that provision.
- Limitations of Liability. The Released Parties are not responsible for: (1) any incorrect or inaccurate information, whether caused by entrants, printing errors or by any of the equipment or programming associated with or utilized in the Contest; (2) technical failures of any kind, including but not limited to malfunctions, interruptions, or disconnections in phone lines or network hardware or software; (3) unauthorized human intervention in any part of the entry process or the Contest; (4) technical or human error which may occur in the administration of the Contest or the processing of entries; or (5) any injury or damage to persons or property which may be caused, directly or indirectly, in whole or in part, from entrant's participation in the Contest or receipt or use, non-use or misuse of any prize. If for any reason an entrant's entry is confirmed to have been erroneously deleted, lost, or otherwise destroyed or corrupted, entrant's sole remedy is another entry in the Contest, provided that if it is not possible to award another entry due to discontinuance or completion of the Contest, or any part of it, for any reason, Station, at its discretion, may elect to hold a random drawing from among all eligible entries received up to the date of discontinuance for any or all of the prizes offered herein. - Disputes. Entrant agrees that: (i) any and all disputes, claims and causes of action arising out of or connected with this 12. Contest, or any prizes awarded, other than those concerning the administration of the Contest or the determination of the winner, shall be resolved individually, without resort to any form of class action; (ii) any and all disputes, claims and causes of action arising out of or connected with this Contest, or any prizes awarded, shall be resolved exclusively by the United States District Court or the appropriate state court located in the Station's listening area; (iii) any and all claims, judgments and awards shall be limited to actual out-of-pocket costs incurred, including costs associated with entering this Contest, but in no event attorneys' fees; and (iv) under no circumstances will entrant be permitted to obtain awards for, and entrant hereby waives all rights to claim punitive, incidental and consequential damages and any other damages, other than for actual out-ofpocket expenses, and any and all rights to have damages multiplied or otherwise increased. SOME JURISDICTIONS DO NOT ALLOW THE LIMITATIONS OR EXCLUSION OF LIABILITY FOR INCIDENTAL OR CONSEQUENTIAL DAMAGES, SO THE ABOVE MAY NOT APPLY TO YOU. All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, or the rights and obligations of entrant and Sponsor in connection with the Contest, shall be governed by, and construed in accordance with, the laws of the state in which the Station is located, without giving effect to any choice of law or conflict of law rules (whether of the state in which the Station is located or any other jurisdiction), which would cause the application of the laws of any jurisdiction other than the state in which the Station is located.
- 13. Entrant's Personal Information. Information collected from entrants is subject to Station's Privacy Policy, which is available on the Station's website under the "Privacy Policy" link. All entry blanks, forms, devices, and materials gathered during the course of entry, as well as all information contained on or within, shall become the sole property of Station to be used, disposed of or destroyed in its sole discretion. Station is not responsible for any incorrect or inaccurate information entered by website users, and assumes no responsibility for any error, omission, interruption, deletion, defect, delay in operation or transmission, communications line failure, theft or destruction or unauthorized access to Station's website.
