CLASSIC ROCK 97LAV'S "FANUARY" CONTEST OFFICIAL RULES

A complete copy of these rules can be obtained at the offices of radio station WLAV-FM ("Station"), owned and operated by Cumulus Media Holdings Inc. or one of its subsidiary companies, 60 Monroe Center St. NW, Suite 300, Grand Rapids, MI 49503, during normal business hours Monday through Friday or by sending a self-addressed, stamped envelope to the above address.

The Station will conduct the **Classic Rock 97LAV's "Fanuary"** Contest (the "Contest") substantially as described in these rules, and by participating, each participant agrees as follows:

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility. On or about 11:00 am ET on January 28, 2020, Station will select one (1) entry for the Grand Prize in a random drawing from among all valid entries received by Station during the Contest Period for the BIG SUIT: A Tribute to the Talking Heads Grand Prize. On or about 11:00 am ET on January 28, 2020, Station will select one (1) entry for the Grand Prize in a random drawing from among all valid entries received by Station during the Contest Period for the Thunderstruck: America's AC/DC Tribute Grand Prize. The winning entrant will be contacted using the email address and/or telephone number provided with the entry and may be awarded the prize (subject to verification of eligibility and compliance with the terms of these rules). Station's decisions as to the administration and operation of the Contest. Failure to respond to the initial winner are final and binding in all matters related to the Contest. Failure to respond to the initial verification contact within three (3) days of notification will result in disqualification.

7. Entry Conditions and Release. questions concerning the construction, validity, interpretation and enforceability of these Official Rules, or the rights and obligations of entrant and Station in connection with the Contest, shall be governed by, and construed in accordance with, the laws of the state in which the Station is located, without giving effect to any choice of law or conflict of law rules (whether of the state in which the Station is located or any other jurisdiction), which would cause the application of the laws of any jurisdiction other than the state in which the Station is located.
