97 WLAV'S "KEYWORD TO KEY WEST" CONTEST OFFICIAL RULES

A complete copy of these rules can be obtained by contacting radio station WLAV ("Station"), 60 Monroe Center NW, #300, Grand Rapids, MI 49503 during available business hours Monday through Friday, on the Station website www.wlav.com, or by sending a self-addressed, stamped envelope to the above address.

The Station will conduct the **97 WLAV's "Keyword To Key West"** Contest (the "Contest") substantially as described in these rules, and by participating, each entrant agrees as follows:

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility. This Contest is open only to legal U.S. residents of the Station's Designated Market Area ("DMA") as defined by Nielsen Audio, excluding Florida and New York residents, age Twenty-One (21) years or older at the time of entry with a valid Social Security number, who have not won a prize from the Station in the last 30 Days or a prize valued at \$500 or more in the last year, and whose immediate family members or household members have not won a prize from the Station in the last 30 Days or a prize valued at \$500 or more in the last year. Void where prohibited by law. Employees of Station, Cumulus Radio LLC, and each of their parent companies, affiliates, related entities and subsidiaries, promotional sponsors, prize providers, advertising agencies, other radio stations serving the Station's DMA, and the immediate family members and household members of all such employees are not eligible to participate. The term "immediate family members" includes spouses, parents and step-parents, siblings and step-siblings, and children and stepchildren. The term "household members" refers to people who share the same residence at least three (3) months out of the year. The Contest is subject to all applicable federal, state and local laws and regulations. Participation constitutes entrant's full and unconditional agreement to these Official Rules and Station's decisions, which are final and binding in all matters related to the Contest. Winning a prize is contingent upon fulfilling all requirements set forth herein.

- 2. Contest Period. The Contest entry period will begin at 9am ET on Tuesday, November 8, 2022 and will run weekdays from 6am ET until 5:05pm ET through Monday, December 12, 2022 (the "Contest Period"). There will be no Contest on Thursday, November 24, 2022 or Friday, November 25, 2022. The Station's computer is the official time keeping device for this Contest.
- 3. **How to Enter.**

On-Air: Listen to the Station weekdays for at least one hour between 9a and 6p ET during the Contest Period. At or around 9:05a, 10:05a, 11:05a, 12:05p, 1:05p, 2:05p, 3:05p, 4:05p and 5:05p each weekday during the Contest Period, the Station will announce a keyword (each a "Keyword"). The immediately following weekday during the Contest Period, listen to the Station at or around 6:05a, 7:05a, and 8:05a ET (each, a "Sounder Hour"). When the Station announces the cue-to-call for the previous day's Contest Keyword, listeners must call the Station at 616-459-9797. Starting with caller #25, the first caller to correctly identify the previous day's Keyword, as determined by the Station in its sole discretion will be the qualifier for that Sounder Hour (each, a "Qualifier"), who will have a chance to win the Contest prize. Time Delay Between Over-the-Air Analog Signal and Internet Broadcast: Due to the time delay that exists between the Station's analog over-the-air signal and the Station's online webcast, listeners who listen to the Station online may hear the cue to call later than listeners listening to the Station's analog over-the-air signal. As a result, the odds of an online listener entering this Contest on-air may be diminished.

4. **Winner Selection.** On or about 7:00am ET on TUESDAY, DECEMBER 13, 2022, Station will select ONE (1) potential winner in a random drawing from among all Qualifiers. The winning entrant will be contacted using the email address and/or telephone number provided at the time the listener became a Qualifier and may be awarded the prize (subject to verification of eligibility and compliance with the terms of these rules).

Station's decisions as to the administration and operation of the Contest and the selection of the potential winner are final and binding in all matters related to the Contest. Failure to respond to the initial verification contact within three (3) days of notification or failure to claim the prize within three (3) days of verification as a winner will result in disqualification and forfeiture of the prize.

- Verification of Potential Winner. THE ELIGIBILITY OF ALL POTENTIAL CONTEST WINNERS 5. IS SUBJECT TO VERIFICATION BY STATION WHOSE DECISIONS ARE FINAL AND BINDING IN ALL MATTERS RELATED TO THE CONTEST. The potential winner may be notified by email and/or telephone call after the date of random drawing and/or winner determination. The potential winner will be required to sign and return to Station, within three (3) days of the date notice is sent, an affidavit of eligibility and a liability/publicity release (except where prohibited) to claim the prize, if applicable. A winner who returns the affidavit of eligibility and liability/publicity release will be deemed to have accepted the contest prize and thereafter will not be permitted to rescind their acceptance of the prize and/or return the prize. If a potential winner cannot be contacted, fails to sign and return the affidavit of eligibility and/or the liability/publicity release within the required time period (if applicable), or if the prize or prize notification is returned as undeliverable, potential winner forfeits prize. In the event that the potential winner of a prize is disqualified for any reason, Station may award the applicable prize to an alternate winner by random drawing from among all remaining eligible entries. The winner will receive: A trip for two (2) people (the winner and one guest) to RokIsland Fest in Key West FL, to include: (i) round-trip coach-class airfare for winner and one guest from the airport located closest to winner's residence to Key West International Airport (or such other area airport as determined by Station); (ii) five (5) nights single-room, double-occupancy (for winner and one guest) hotel accommodations in a hotel in the Key West area as selected by Station; (iii) two (2) (for winner and one guest) Sapphire Premier Passes to RokIsland Fest, scheduled for January 17, 2023 through January 21, 2023; and (iv) Five Hundred Dollars (\$500 US) in gift cards, check, or cash (as determined by Station).

MEALS AND GROUND TRANSPORTATION ARE NOT INCLUDED IN THE PRIZE.

The approximate retail value ("ARV") of each prize is SIX THOUSAND FIVE HUNDRED THIRTY-FOUR dollars (\$6,534 US).

TOTAL ARV OF ALL CONTEST PRIZES IS: SIX THOUSAND FIVE HUNDRED THIRTY-FOUR dollars (\$6,534 US).

For entry to the prize event(s), each event attendee may be required to show valid proof of vaccination against the COVID-19 virus and/or valid proof of a negative test for the COVID-19 virus within 72 hours (or such other time as the event organizers require) prior to the event(s).

Other restrictions may apply.

<u>Trip must be taken between January 17, 2023 and January 22, 2023</u>. Travel dates to be determined by Station. Winner and guest must travel on the same itinerary. Winner's guest must be Twenty-One (21) years of age or older. Prize is non-transferable and no substitution will be made except as provided in these Official Rules, in the Station's sole discretion.

If any prize or a portion of any prize is postponed, cancelled, or otherwise unavailable due to disease, epidemic, pandemic, quarantine, any acts of government and/or any reason that is beyond the control of Station or any Sponsor, then no substitution shall be provided. Station and any Sponsors make no representation or warranty about the safety of any prize. By accepting and using a prize, each winner acknowledges and assumes all risks of accepting and using the prize, and any other risks associated with the prize.

- 7. Entry Conditions and Release. Any attempt by any person to deliberately undermine the legitimate operation of the Contest may be a violation of criminal and civil law, and, should such an attempt be made, Station reserves the right to seek damages from any such person to the fullest extent permitted by law. Station's failure to enforce any term of these Official Rules shall not constitute a waiver of that provision.

not limited to malfunctions, interruptions, or disconnections in phone lines or network hardware or software; (c) unauthorized human intervention in any part of the entry process or the Contest; (d) technical or human error that may occur in the administration of the Contest or the processing of entries; or (e) any injury or damage to persons or property that may be caused, directly or indirectly, in whole or in part, from entrant's participation in the Contest or receipt or use, non-use or misuse of any prize. Entrant agrees that: (a) any and all disputes, claims and causes of action arising out of or connected with this Contest, or any prizes awarded, shall be resolved individually, without resort to any form of class action; (b) any and all disputes, claims and causes of action arising out of or connected with this Contest, or any prizes awarded, shall be resolved exclusively by the United States District Court or the appropriate state court located in the Station's listening area; (c) any and all claims, judgments and awards shall be limited to actual out-of-pocket costs incurred, including costs associated with entering this Contest, but in no event attorneys' fees; and (d) under no circumstances will entrant be permitted to obtain awards for, and entrant hereby waives all rights to claim punitive, incidental and consequential damages and any other damages, other than for actual out-of-pocket expenses, and any and all rights to have damages multiplied or otherwise increased. SOME JURISDICTIONS DO NOT ALLOW THE LIMITATIONS OR EXCLUSION OF LIABILITY FOR INCIDENTAL OR CONSEQUENTIAL DAMAGES, SO THE ABOVE MAY NOT APPLY TO YOU. All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, or the rights and obligations of entrant and Station in connection with the Contest, shall be governed by, and construed in accordance with, the laws of the state in which the Station is located, without giving effect to any choice of law or conflict of law rules (whether of the state in which the Station is located or any other jurisdiction), which would cause the application of the laws of any jurisdiction other than the state in which the Station is located.
- 13. **Entrant's Personal Information.** Information collected from entrants is subject to Station's Privacy Policy, which is available on the Station's website under the "Privacy Policy" link. Station is not responsible for any incorrect or inaccurate information entered by website users, and assumes no responsibility for any error, omission, interruption, deletion, defect, delay in operation or transmission, communications line failure, theft or destruction or unauthorized access to Station's website.
